Firm-fixed price contract to produce and deliver HUSK shipping crates in support of the Rock Island Arsenal, Joint Manufacturing and Technology Center (RIA-JMTC). The HUSK is the replacement cab for the Heavy Equipment Transporter (HET), and the replacement cab provides greater protection for soldiers. JetCo produced 80 HUSK replacement cabs, transporting them in groups of 4 on oversized flatbeds.
